Some key comments from the report received from London NPC (Nov 2019)

What we did: We reviewed how the local area works within and across three key areas:

Maintaining people's health and wellbeing at home
Care and support when people experience a crisis
Supporting people when they leave hospital.

What we found:

Organisations intended to work together but mostly focused on their own goals. Although there was good planning between services, the way services were funded did not support them to work together Organisations: were prioritising their own goals over shared responsibility to provide person centred care did not always share information with each other which meant they weren't able to make informed decisions about people's care were not prioritising services which keep people well at home planned their workforce in isolation to other services.

The regulatory framework focuses only on individual organisations.

Recommendations

Reform of planning and commissioning of services.

An agreed joint plan, funded in the right way, should support older people in their own homes, help them in an emergency, and then to return home safely.

A new approach to system performance management. This would measure how organisations collectively deliver improved outcomes for older people. Joint workforce planning.

This would allow flexible and collaborative approaches to staff skills and career paths.

Better oversight of local system performance.

New legislation so CQC could regulate how people and organisations work together to support people to stay well.

4. In The News. October

It was 50 years ago today...
So may I introduce to you
The coin you've known for all these
years?

Arnold Machin's 7-sided coin.



The 50p coin entered circulation on 14 October 1969, in the run-up to D-

Day on 15 February 1971, when the UK moved to a decimal currency. Guardian Money searched prices of goods in 1969 and compared them with today. This shows that in real terms, food, clothes, electrical goods and holidays have collapsed in price and we can afford much more. But there has been a vast relative increase in the price of housing. A look through the Guardian's classified job adverts on the day the 50p was launched gives a snapshot of what real jobs paid. The Open University, which had just been established, was hiring professors at £3,780 a year (equal to £62,532 today), lecturers on a range of £1,240 to £2,850 (£20,153-£47,147), and secretaries on £756-£1,068 (£12,506-£17,668).

The Open University is still hiring — and its adverts suggest that real pay for academics has barely edged ahead in 50 years. It currently has an advert for a professor of economics on a range of £67,700-£75,800, while it pays lecturers £33,000 to £49,000. But the secretary job pays lots more in today's money, with the OU advertising a role at £23,000 to £26,000.

The Royal Mint produced no £2 or 20p coins in 2017 as people used change in a rush to get rid of their pound coins as the old ones went out of circulation.

5. History in Stamps.

Charity surcharge postage stamps.
Alternative Funding the NHS?

Charity Stamps are issued to raise money for a particular purpose (such as a charitable cause) and sold at a premium over the postal value.



Typically the stamp shows two denominations separated by a plus

sign, but in many cases the only denomination shown is for the postage rate, but the buyer pays more.

The first "semi-postal" was actually a postal card sold to commemorate the Uniform Penny Post in 1890, the United Kingdom of Great Britain and Ireland issued a card with a face value of one penny, but sold it for sixpence, with the difference given to a fund for postal workers.

Some of the first semi-postal stamps which were issued by the Australian colonies of New South Wales and Victoria, who both marked the Diamond Jubilee of Queen Victoria in 1897 with stamps sold for 12× increase over the face value.



There's a 1945 New Zealand "Health" stamp charging two pence for postage and a premium of one penny for charity.



The Royal Mail in 1975 sold this stamp for Health and Handicap funds with a $4\frac{1}{2}p$ denomination and a premium of $1\frac{1}{2}p$ for charitable causes making the total cost 6p, with funds going to health and handicap charities. The stamp issue was not considered a success and there have been few UK semipostal issues since.

Other countries have had more success.



This 1998 USA breast cancer awareness stamp had a surcharge of 6 cents. It has been re-issued several times, the most recently in 2014.

6. From the Archives

Bah Humbug Mr Adam.

The Dover Junior Imperial and Constitutional Association had a joint meeting with the Dover Women's Suffrage society, reported in the local newspaper of 18 March 1910.

Mr Alex Adam, a member of the Junior Imperial Association thought that women would be degraded by active involvement. The Imperialists as a whole opposed women's suffrage because they were told that at the Creation man was destined to rule over women. Speaking at the meeting was Dr Brunyate, Dover's first medical practitioner who attended Girton College 1892-7, did her medical training in Durham, and obtained a doctorate from St Hugh's College, Oxford. She was a co founder of Dover Women's Suffrage Society in 1909 and was later to become Assistant Medical Officer of Health of Lindsey, Lincolnshire. 1872-1937.

7. Environmental Matters.

At our October 2019 branch meeting the following motion proposed by Tony Staunton, seconded Jo Corke. This branch formally resolves to offer full support to the next Global Climate Strike day on November 29th and calls upon the Trades Councils and their affiliated branches in the South West to support and mobilise for the day.

It was carried unanimously and it was agreed that the motion from the SW RMB should be sent to the SW TUC with a request to forward it to TCs. Our branch TC delegates can raise it at TC themselves too.

Following the recent declarations of a climate emergency by Bristol City Council, South Gloucestershire Council and the University of Bristol, staff at UWE have called on UWE's board of governors to declare a climate and ecological emergency on behalf of UWE.

The TUC South West, representing half-a-million workers in the region, wants to see trade unions at the heart of every workplace discussion.

The TUC calls for:

*A Just Transition Commission: a cross-party national commission including business, consumers and unions to plan a clear and funded path to a low-carbon economy.

- *Workplace Transition
 Agreements: to put workers' voices
 at the heart of transition plans in
 every workplace where change is
 required.
- *Transition skills funding: so that every worker has access to training in the new skills needed for a low carbon economy, and guaranteed pathways to new work.
- *Employment standard protections: to ensure new jobs in the low carbon economy are not of lower quality than jobs that are changed or superseded.
- *Trade Union Green Reps: trained and supported to champion environmental protection at work.
