UCU: we are stronger together

### National update

#### Your branches

Since prisons have moved to restricted regimes, your UCU branch officers have been working really hard to support members with queries and concerns relating to home-working, micromanagement, equipment and addressing queries relating to on-line learning.

### UCU representation with employers

At a national level we have been trying to secure weekly meetings with each of the Prison Education Framework (PEF) providers in order to ensure that UCU is fully consulted over plans in relation to the recommencement of face to face delivery (when it happens). I'm pleased to report that 3 out of 4 providers are engaging with us on this basis. Unfortunately, Weston College have failed to give us a date for a meeting and continue to be lagging significantly behind the other providers on a number of counts. Their engagement with the union being just one shortcoming. We will be putting Weston College on notice that a continuation of their current approach to industrial relations is likely to lead to a dispute.

## UCU representation with HMPPS

We continue to be in close contact with our colleagues in the POA and alongside 8 other trade unions who work within the prison estate (Justice Unions in Prisons Alliance), we have written to the Secretary of State for Justice, Sir Robert Buckland a comprehensive set of demands in a 'Recovery strategy from COVID-19 restricted regime' which focuses on the health and safety framework we expect to be in place as part of a transition to a normal routine.

## Successful intervention to prevent breach of restricted regime

Following moves by one of the private providers in the YOI estate who notified staff that they would be expected to return to face to face delivery this week, we have received assurance from the chair of the POA, that under no circumstances would that be taking place. We have therefore been able to intervene and the employer has since reversed those proposals for the time being. It is really important that members escalate any moves to breach the current restricted regime by notifying your branch officers immediately.

#### **Representing members in parliament**

We have also 'virtually' met with Lyn Brown, MP, the new shadow prisons minister. We delivered a brief presentation to the shadow minister which outlined some of the amazing work that our members carry out in prisons, how dedicated you all are and also highlighted that unfortunately this work and dedication is not valued in the way that it should. We set out that your skills, dedication and working conditions, were not reflected in your pay, terms and conditions and moved on to outline the lack of joined up strategy when it comes to offender learning given the nature of the PEF contract. We are really pleased that the shadow minister, committed to working with UCU on asking questions of the government not just in respect of the current crisis but also supporting our work on a fairer future for prison education and our members who work there.

#### **UCU training**

We are really pleased to announce that the prison rep health & safety training has been so popular it became over-subscribed within just a few days. We are in the process of setting up a second course as soon as we have found a tutor. Any reps who are on the waiting list will automatically be enrolled on to the new course. #### **PeoplePlus**

My heart goes out to all of those that have lost somebody to this horrible virus or have had to battle with it themselves. Most of us seem to know somebody who has suffered and it hits home how serious the situation is. Nationally the talk is about how we come out of lockdown and when this may be. Our focus must be on the continued health and well-being of our members as inevitably we are asked to return to the prison sites.

In the PeoplePlus branch the committee now has a weekly call with senior management during this crisis. We will emphasise the importance of rigorous risk assessments agreed with the union. The availability of PPE and ongoing social distancing are key to any discussions between the prison and management. I have also raised questions around the information on cases at each prison and whether testing will be undertaken before we return. We must also consider new ways of working with our students, smaller classes, some remote teaching and other alternatives. I am also keen to ensure that those in vulnerable groups and those who have needed shielding continue to be protected.
