Green New Deal bargaining advice and model claim

The key piece of work has been the development and launch of a UCU Green New Deal (GND) model claim and associated bargaining guide for branches.

The comprehensive bargaining advice sets out strategies and references evidence to support branches advancing climate and sustainability agendas within their



workplace, together with model claim letters. There is a specific UCU training course to accompany the GND.

We have worked with SOS-UK (Students Organising for Sustainability, a charitable arm of NUS) with the aim of developing closer links with local branches and student unions in driving through successful claims. The claim covers the following key bargaining objectives and meets the policy objectives set by Congress 2020 motions 39 and 40:

- institutions to declare a climate emergency
- agree concrete time limited action plans on environmental policies
- embed climate and climate justice into curriculums
- sign up to ethical investment and banking strategies
- review food and land use
- travel policies and carbon and energy management commitments.

These have also been developed into 'quick guides' as stand alone claims to enable branches some flexibility over which issue they wish to prioritise. See: **UCU - Green new deal**


Staff and student solidarity

We have worked very hard over the past year to ensure that we build upon the staff/student solidarity shown with the climate stoppages in September 2019. This has seen us work alongside the student-led Teach the Future campaign in joint responses to the government over critical green recovery investment and share their call for a climate emergency education act.

UCU alongside BFAWU, PCS and NEU supported the Friday's for Future September 2020 day of action and produced a **six Covid safe steps to show our solidarity to the Fridays for Future movement**.

CPD courses

We have for the first time this year rolled out a number of climate & sustainability themed CPD courses available free to all UCU members: introduction to sustainability; embedding climate education into the curriculum.



These have been exceptionally popular with members and have

seen recruitment of new green reps and has allowed us to share this area of the union's work with the broader membership. Sessions have been run for every devolved nation and English region with over 650 participants over 4 months.

There will be another two CPD sessions in 2021: decarbonise & decolonise - meeting the UN's sustainable development goals; and how to run a climate themed learning week. Email us at **environment@ucu.org.uk** for more information.

UCU resources

To underpin UCU's commitment to this area of work, we have also seconded one day a week a member of SOS-UK to help progress our climate and sustainability policy. This has had the additional benefit of increasing our joint work with SOS-UK on the GND at branch level.

Political work

Over the past 12 months UCU has continued with its joint work with other trade unions via the TUC's TUSDAC (Trade Union Sustainable Development and Advisory Committee) with its focus on Just Transition and the Green Jobs Taskforce. UCU has been involved in meeting with government officials in making the case that the education sector needs to play a pivotal role in any industrial strategy as part of a green recovery. This has included lobbying key parliamentary groups which will be a continued focus over the coming weeks and months as set out by the general secretary.

We have submitted responses to various calls for evidence as part of the green recovery and have responded to Educational International's manifesto We have joined the COP-26 coalition and are encouraging all branches to do the same you can sign up here: COP26 - COP26 Coalition

UCU climate & sustainability conference

Following a call from existing green representatives for a forum within which they can share best practice, establish regional networks and coordinate a response to things such as COP-26 and organising conference motions, UCU's first climate & sustainability annual conference which was open to all members – branch nominated green reps and those interested in getting involved, was held in March 2021.

UCU's COP 26 campaign: decarbonise & decolonise 2030

COP26 - the 2021 United Nations climate change conference, is scheduled to take place in Glasgow, Scotland 1-12 November 2021. It has already been postponed from 2020 and we need to see our national and international leaders making meaningful commitments to address the climate and ecological emergency in a just and fair way.

UCU's COP-26 campaign

The UK will be hosting the 26th United Nations climate change Conference of the Parties (COP26) in Glasgow on 1-12 November. The summit will bring together parties from UN member states to agree on action towards the goals of the Paris Agreement and



the UN Framework Convention on Climate Convention. In its role as COP26 president five priority areas have been agreed for the UK, they include: adaption & resilience; nature; energy transition; clean road transport; and finance. The role of education in delivering on these priority areas and to address the climate emergency in a just and fair way is absolutely critical. We as UCU are calling on members to join together and take action to ensure the agreements that come out of this year's COP fundamentally include education as a key enabler.

UCU's COP-26 campaign aims:

- 1. develop specific COP26 campaigns and claims around embedding climate justice and learning. See here for more information on our COP26 climate themed learning month and Decarbonise & Decolonise 2030 model claim.
- 2. international collaborations - we are working with ITUC, ETUCE and Educational International on a coordinated approach to COP26.
