Smoking Ban



Restrictions on smoking in workplaces and public places come into effect in Wales from the beginning of April and in England from the 1st July. The TUC has produced guidance for trade unions outlining what steps should be now taken now to ensure the phased introduction of restrictions and support for those who currently smoke. TUC launch internet guide for reps

Whether it's in researching legislation, connecting with other reps, or distributing union material to members, the internet is becoming ever more important to the work of the UK's 220,000 plus trade union reps. A 2004 survey found that two thirds of reps were using the internet more than twice a week and numbers continue to grow. The TUC has put together a short guide to introduce reps to some of the services out there to help them in their roles. Corporate Killing Bill

The Corporate Manslaughter Bill has now completed its passage through both the House of Commons and the Lords. The Bill now has to go back to the Commons. No timetable has been set for this although the Bill must get Royal assent by early June or else it falls.

Trade unions support the broad intentions of the legislation. However, the TUC is concerned that the government has not addressed the issue of the role of individual directors. The TUC believes that the Bill should have established Secondary Liability for those who connive, conspire, or collude in an act which results in death and have continued to campaign for a specific duty on Directors in respect of health & safety.

Safety Representatives Rights

Over the past three years the HSC have been looking at ways of improving worker involvement, including the way that safety representatives operate. This has led to a number of changes including the new safety representatives' pages on the HSE website, guidance for safety representatives on asbestos and sickness absence, and advice to inspectors. In addition the HSC consulted on a number of changes including placing a duty to respond to representatives on safety representatives, and requiring employers to consult with safety representatives on risk assessments.

However at the March meeting of the HSC, the Commission failed to reach agreement on these changes despite strong arguments from the TUC Commissioners. They did however agree to continue discussions on the issue. It was agreed to revise the current "Brown Book" on safety reps and committees and work on that will be starting shortly.

24-7 work life balance

Last Autumn Keele University conducted its annual 24-7 survey into working life and work life balance. UCU publicised it and a number of UCU members responded.

CIPD issues new stress guidance

Rising levels of work related stress have prompted new guidance for employers. Around one in five people experience high levels of stress at work, costing UK employers an estimated £9.6 billion per year. The Chartered Institute of Personnel and Development (CIPD) has published three new guides, in association with the HSE. European Health and Safety Week 22 – 26 October 2007

This is an annual event organised by the European Health and Safety Agency. This year the main focus will be on Musculoskeletal Disorders. The TUC and HSE are working on a range of checklists for safety representatives on Manual Handling and RSI, and there will be four training events in various parts of the country on MSDs. The Wednesday of the Week is National Inspection Day and there will be an inspection checklist on MSDs available for use by safety representatives. New Construction Regulations rumpus

The HSC approved new Construction regulations last year. These were generally supported by trade unions and simplified the management arrangements for construction work while retaining worker protection. As such they were seen as a model of "better regulation" as opposed to "de-regulation". They were approved by the minister last month and laid before Parliament, with a view to implementation on 6th April.

Unusually for health and safety regulations, these are being opposed within the House of Commons. Andrew Selous MP, Shadow spokesperson for health and safety, has called for a debate on the CDM. On 15 March David Cameron laid an EDM in House, "praying" that the CDM be annulled. No date has been set for the debate but it is expected in the next fortnight. Construction unions, and the TUC have been supportive of the new regulations and the TUC will be preparing a parliamentary briefing on the issue prior to the debate.

Mesothelioma

"Mesothelioma: The human face of an asbestos epidemic" is a DVD produced by the national Forum of Asbestos Victim Support Groups. It contains an 8-minute presentation plus interviews with the relatives of a few of the many thousands of workers who have already died of mesothelioma after being exposed to asbestos by their employers. This terrible disease is an incurable cancer of the pleura, the lining of the chest cavity, and can result from a relatively brief exposure to asbestos dust. It can take anything between 10 and 50 years to develop, and has affected all kinds of workers from engineers and joiners to teachers and consultant surgeons.

UCU runs health and safety courses which are open to all members but in particular to new health and safety reps and those who are interested in becoming a health and safety rep.

We are currently in the middle of running the UCU H&S stage 1 course which consists of the following 5 x two day modules;

- Health and Safety Induction
- Understanding Health and Safety Law
- Using your rights as H&S rep
- Dealing with Accidents & Tackling Hazards
- Trade Union Action to Tackle Stress

Modules 2-5 should only be attended by those who have completed the health & safety induction course.

We also run a two day Harassment and Bullying course and we are currently working on a one day Tackling Harassment and Bullying at Work conference planned for September 2007.
