National Negotiations Update

At a meeting of New JNCHES on 5 May, the HE employers revised their offer in response to the trade side claim. The employers increased their offer of a non-consolidated payment equivalent to 0.25% of the pay bill to 0.4% (non-consolidated) of the pay bill. The employers invited the trade unions to discuss the distribution of the offer. Although the employers indicated a willingness to engage in further discussion on training and career development, they again refused to enter into a dialogue to secure a nationally-agreed approach on job security.

In response, the trade union side noted the slightly improved offer but stated that:

- The employers' refusal to enter national level talks on job security was unacceptable;
- The employers offer was for a real terms reduction in pay for the second year running;
- We are not interested in discussing a non-consolidated offer;
- We are not interested in discussing how to distribute a pay cut.

The trade unions asked the employers' to review their position. Another national-level

meeting between the unions and employers has been agreed for Friday 28 May.

Joint Union Campaigning

Branches/LAs are encouraged to work with sister unions on their campuses to campaign on the issues raised in our national claim (job security, pay, and national framework issues). Branches/LAs are reminded that materials are available on the joint union website:

Following the JNCHES meeting, the union side held a productive and useful discussion about co-ordinating joint union activities to focus local attention on the unacceptable stance of the national employers' association to our claim. Further talks between the unions will be held to develop the initiative but the initial proposal is for campus unions to organise a lobby some time during the week commencing 7 June. It is hoped that, where possible, joint activities can take place on 10 June.

Branches/LAs are asked to hold discussions with sister campus unions about holding a campaigning event on 10 June or, if that is

not possible, during the week commencing 7 June. Further information will follow.

Membership Records

Your assistance is essential in ensuring the smooth running of our communications, democratic structures and ability to run industrial action ballots.

As you will be aware, the current industrial relations environment is very challenging. The HEC has already noted the employers refusal to engage properly with the join union claim to protect job security and protect salaries.

If it is necessary to ballot for action, it is important that we minimise the risk of legal challenge to the accuracy of our membership records. In the week commencing 10 May, our membership administrators will be contacting branches/LAs asking you as a matter of urgency to look at the membership list we hold for you and update your branch records. We understand that branches/LAs are busy but this should be regarded as a key organisational priority and task.
