### 1. The Joint HE trade union national claim

The first meeting at New JNCHES took place on 26 March following the submission of the joint unions' national claim the week before. At the meeting the trade union side set out the details of the claim and the employers made an initial response. No offer was made and both side agreed to schedule an additional meeting as part of the negotiating timetable on 14 April.

#### The joint unions' claim

The claim was drafted by UCU's national negotiators and agreed by the Higher Education Committee in February this year. The claim focuses on a 'keep up and catch up' pay offer, coupled with a pay equality claim that builds on work undertaken following last year's agreement by seeking to address the position of casually employed / zero hours staff, hourly paid lecturers, the HE gender pay gap and pay equality issues above the 51 point spine. All the central elements of the claim approved by the HEC were endorsed by the joint trade union side, consisting of UNISON, Unite, EIS and GMB, before being submitted to the employers on 18 March.

#### What happens next?

A series of negotiating meetings have been agreed following the initial meeting on the 26 March. New JNCHES will meet again on Tuesday 14 April, Friday 24 April, and Tuesday 12 May. We will keep branches updated on the progress of the negotiations.

### 3. Ending zero-hours contracts in further and higher education

#### Now's the time to take the fight to the employers over zero-hours contracts

Alongside other unions, UCU continues to hammer away in the press and Parliament to raise the pressure for legislation that would outlaw zero hours contracts. But our national campaign is also focused firmly on raising pressure on key employers and driving change in our institutions. And we're making headway too. At Edinburgh and now Glasgow Universities there has been positive progress in moving away from using zero hours contracts and the union has capitalised on this by writing to eight other Scottish universities urging them to get on board and commit to negotiations. At key target institutions in England, active campaigns have been built with national assistance and several have negotiations in progress. The public and political profile of zero hour's contracts is not going to diminish and our campaign has real momentum. Now is the time to turn up the pressure on your employer by building local campaigns, plugging into the national campaign, and pressing for negotiations.
